Contractual and Professional Services	Uvalde County will subgrant with the Bluebonnet Children's Advocacy Center (BCAC) to provide a child-friendly, safe, neutral environment for Robb Elementary school victims who have been exposed to abuse and trauma. The Center works to lessen the emotional trauma to child survivors through individual and group counseling and advocacy. Blue Bonnet has provided contract therapist to assist children and their families who are impacted by the Robb Elementary shooting. Uvalde County will contract with BCAC to provide \$410,850 in services over the 28-month grant period. Contractual and Professional Services	Uvalde County will subgrant with Nueva Vida to provide professional, bi-lingual, and bi-cultural psychological services. Services available for victims include individual and group counseling (at the office, at home, or other rehabilitation locations) for all ages, behavioral medication management, psychological pre-surgery screenings, forensic counseling for families, and supportive learning services. Providers establish and maintain working relationships with family members, physicians, school personnel, attorneys, and other individuals critical to their client's growth and development. Nueva Vida has hired two full-time providers and contracted with two psychiatrists (one for children, one for adults) to serve Robb Elementary School shooting survivors. Uvalde County will contract with Nueva Vida to provide \$393,750 in services over the 28-month grant period. Contractual and Professional Services	Uvalde County will subgrant with the Children's Bereavement Center to serve child victims of the Robb Elementary school shooting to cope with residual trauma and grief. Grief support services offered include, grief counseling, grief camps, and support groups for children and their caregivers. As a result of the shooting, the CBC established a permanent presence in the county and has hired a counselor for the 6th and 7th graders who will attend Morales Junior High for Fall 2024 who would have been directly affected by the Robb mass violence, and a counselor for teachers and first responders impacted by the shooting. Uvalde County will contract with the Children's Bereavement Center to provide \$500,000 in services over the 28-month grant period.
